Rules and Regulations

1. The price per ticket is \$100.00 (One hundred dollars), payable by cash, check or charge via Visa or MasterCard only (made to the order of Little Sisters of the Poor) and mailed to: Little Sisters of the Poor – St. Louis Residence, Attn: Director of Development, 3225 North Florissant Ave., St. Louis, MO 63107.
 2. The prize structure will be as follows: First Prize - \$20,000, Second Prize - \$3,000 and Third Prize - \$2,000. Your chances are 1 in 1,200 to win one of the prizes.
 3. The tickets will be collected in the order received. The checks will be deposited upon receipt. Checks that are returned for insufficient funds or other reasons will disqualify the ticket covered by such check. Any fees accrued will be charged to the buyer.
 4. All tickets must be received prior to the drawing on April 29, 2010. If mailed, tickets must be postmarked no later than April 26, 2010 or if the raffle is extended no later than May 26, 2010 in order to be included in the drawing.
 5. The maximum number of tickets that will be sold is 1,200. Ticket sales will cease when that number is reached, and any checks received following the cutoff will be returned to the sender.
 6. All prizes are subject to, and the Winners are fully responsible for federal, state and local income taxes. Little Sisters of the Poor have no responsibility for the payment of any taxes associated with the prize (except for the responsibility to comply with the withholding regulations and requirements of the taxing authorities involved).
 7. Winners must accept ownership of the prize(s) by May 3, 2010. The award will be awarded one week after the drawing to process the proper paper work for the federal, state and local taxing authorities.
 8. The Little Sisters of the Poor – Cash Raffle Committee reserves the right in the event that 1,200 tickets have not been sold by April 29, 2010, to extend the project 30 days past May 29, 2010.
 9. In the event that less than 1,200 raffle tickets have not been purchased by April 29, 2010 or the extended date, if any, Little Sisters of the Poor – Cash Raffle Committee reserves the right to cancel the prize as stated above and conduct a prorated prize distribution. The Winners, in such event, will receive the prorated value of the total received in the raffle, less net expenses, as of April 29, 2010 or the extended date, if any (For example: only 750 tickets are sold and there are \$5,000 in expenses. The Winners will receive: First Prize – 16.6% of \$70,000, Second Prize – 2.5% of \$70,000 and Third Prize – 1.6% of \$70,000. The remaining proceeds will go to the Little Sisters of the Poor). The decision to proceed as a prorated drawing shall be made, and announced publicly, on or before April 29, 2010.
